From the CEO

MelJol has been a pioneer in advocating for the rights of children and youth and has always respected their right to participate in decision-making particularly in those areas that impact their lives. For the past two decades we have used education as a tool for social change with special reference to and emphasis on social and financial education (SFE).

Of late, issues of Financial Education and Financial Inclusion have assumed importance in NGOs as well as in Government programmes in India. The focus is shifting from children to adolescents and the youth. The emphasis is also now on entrepreneurship and skill development. MelJol too has devised its own programmes and modules to respond to this emerging need.

MelJol has consolidated its programmes in rural India primarily in government-aided schools and by partnering with the government. The programmes supported by a grant award of the HCL Foundation are establishing a strong foundation in six districts across three states. We also have interventions in urban areas with underprivileged adolescent youths with the support of Citi Foundation and Rabo Bank. The core team of MelJol continues to work hard to ensure that the programmes are not only implemented effectively but they also anticipate the future by working on fresh modules to suit a fast-changing environment.

MelJol has faced some obstacles particularly on the resource mobilisation front during this year. The funding preference for short-term interventions over process-driven learning poses a challenge to secure programme support. Also, the insistence of funding agencies on direct intervention has halted its Partnership Programme model putting a strain on MelJol's human and other resources. Despite several such hurdles the MelJol team has given its best on many fronts. It has successfully implemented programmes in the districts of Jharkhand, Uttar Pradesh, Maharashtra and Himachal Pradesh. It has continued its partnership with the Education Department in Chhattisgarh. It has been the knowledge partner in Rajasthan and Odisha, supporting NGOs to integrate SFE into their programmes.

I am aware that it is imperative for the Aflatoun Programmes to be dynamic in order to stay relevant in this diverse landscape. As I look back on our organisational engagement in the year 2017-18, I am optimistic that MelJol will continue to add value to the life of children and youth in the future.

OUR VISION

To work towards an equitable social structure with a pluralistic society i.e. a society that is integrated, where different cultures co-exist peacefully.

OUR MISSION

To develop children's citizenship skills by focusing on children's right and responsibilities and providing them with opportunities to contribute positively to the environment using social and financial education tools.

OUR GOALS

Goal 1. Social & financial education is available & accessible to all children with opportunities for their participation to be active citizens in embracing democratic values & live with dignity.

Goal 2. An enabling environment where children's participation is valued and zero tolerance for any form of violation of child rights is fostered.

Goal 3. MelJol as a resource centre for Child rights and social and financial education.

Goal 4. MelJol's institutional capacities as a learning organisation are strengthened towards effective fulfillment of its mission.

MelJol Programs

MelJol's consistent efforts in empowering under-privileged children, adolescents and youth from under-resourced communities in tribal, rural and urban locations, have made it a thought leader in developing child- and youth-centred, developmentally-appropriate and need-based curricula.

MelJol seeks the active involvement and engagement of all stakeholders in the life of the child and youth. This includes school teachers, the education department, local community representatives, institutions, school management committees and parents.

MelJol derives its conceptual framework from international instruments such as The United Nations Convention on the Rights of the Child and the Indian Constitution. MelJol programmes also subscribe to the Sustainable Development Goals of the United Nations Development Programme. MelJol's programmes aim at helping children and young people to think critically; in a scientific manner, as individuals and as members of society.

Aflatot (3–5 years)

The Aflatot programme is an elementary school programme for children usually between 3-6 years of age. It provides an early childhood education programme that lays the foundation for social and financial literacy. The programme builds on research which has shown that early investments result in advantages such as development of social skills and a sound base for financial education that are amplified and reinforced over time. Some of the activities include neighbourhood and market visits, Aflatot camps, Aflatot Journey Box, Aflatot Fair, etc.

Aflatoun Social and financial education Programme (6-13 years)

The Aflatoun programme empowers children to understand the self and build a positive self-image, to better engage with their ecosystem, to learn about child rights and responsibilities, to address child rights violation in a collective manner, to understand the importance of financial and non-financial/natural resources for survival, to practice methods of saving and conserving them. The Aflatoun programme gives children the opportunity to engage, explore, explain, elaborate and evaluate. It uses the constructivist approach to learning by engaging in social financial and entrepreneurial activities. It works with school-going children, out-of-school children and children in child-care institutions.

Aflateen (14–16+ years)

The Aflateen programme helps adolescent and youth to cope with their life transitions better. It helps them to define their goals and future plans by understanding their strengths, weaknesses and available opportunities. The programme gives them space and liberty to reflect on the existing social issues such as gender and gender roles, child marriage, etc. The programme inculcates life skills such as understanding saving and spending, the importance of prioritizing needs and wants, planning and budgeting, as well as achieving personal and professional goals, etc. It informs them about various financial institutions and products. Entrepreneurship is not just viewed as a means of securing a livelihood but as a medium to find solutions to real-life situations faced by adolescents and youth.

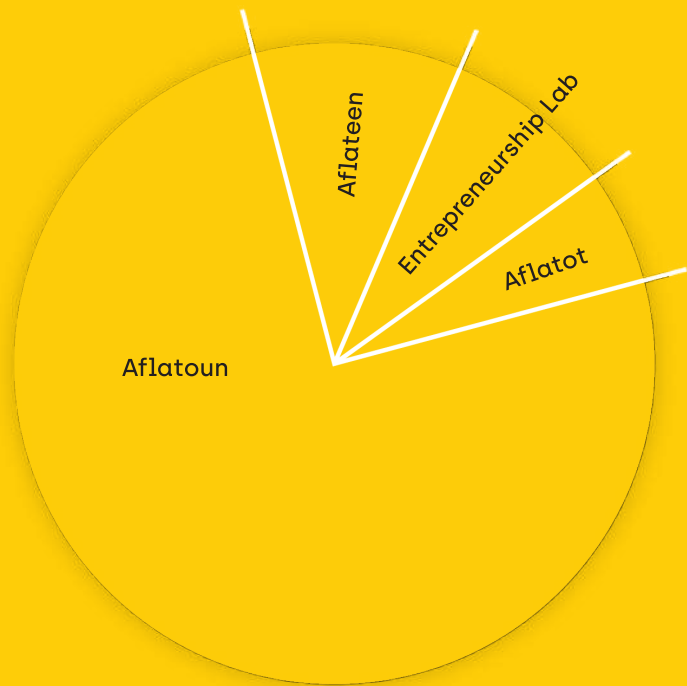
Entrepreneur- ship lab programme (14–20+ years)

The Entrepreneurship Lab is a virtual laboratory with a clear focus on entrepreneurship skills. To achieve this, core and soft skills are honed to a level where the youth can operate in a variety of contexts and work environments. These factors make the Entrepreneurship Lab youth employable and enterprising. Entrepreneurship Lab is conceived as a non-threatening, free and open learning space where adolescents and youth may gain knowledge but it also seeks to nurture the entrepreneurial spark within them.

MeIJoI out-Reach



MeIJoI has worked in six states and sixteen districts reaching out to 1,26,017 children and adolescent youth through its programmes through direct intervention. MeIJoI has reached another 14,63,000 children and youth through its knowledge partnerships with the government and with other NGOs. MeIJoI is working with the Himachal Pradesh Government to pilot the curriculum in schools from three districts. The goal is to scale up the programme across other districts in the state. MeIJoI is also in partnership with Rajiv Gandhi Shiksha Mission of the Education Department of the Chhatisgarh Government to strengthen the Child Cabinet through Aflatoun Programme in 13,000 schools. It is the Knowledge Partner to a Plan International-supported programme in Rajasthan to ensure that the Financial Education programme complements the existing programme of Continuous Concurrent Education. Aflatoun, Aflateen and the Entrepreneurship Lab Programme have been implemented successfully in Maharashtra, Uttar Pradesh, Jharkhand and Delhi.

Highlights of the Year



Every year, MelJol and its partner organizations participate in the Global Money Week organized by the Netherlands-based NGO, Child and Youth Finance International (CYFI). The week-long celebration was conducted from 12th March to 18th March 2018 this year.

This is a unique movement where organizations around the globe spread awareness about saving money and related resources. At MelJol, Skype conferences were organized between children from various locations. Children from Harare spoke to children from municipal schools in Mumbai and children from Delhi interacted with children from Uttar Pradesh. Children shared their experiences and insights of saving under the Aflatoun Social and Financial Education Programme. They also encouraged each other to spread the word to their parents, relatives, friends and other community members. Street plays, poster competitions, debates were organized in various places by MelJol staff and partner organizations.

Wings over Himachal Pradesh

In 2016, MelJol partnered with the Directorate of Elementary Education of the Himachal Pradesh Government to test the Aflatoun Social and Financial Education Programme with 90 schools across three districts (Simla, Bilaspur and Solan). The pilot project is for three years with the aim to further scale up this intervention by introducing it into the existing system. In 2017, MelJol expanded its reach by 30 more schools thus reaching a total of 120 schools.



Hardoi Programme launch

The Aflatoun Programme Launch event was conducted to announce the programme to all the stakeholders and seek their participation. The MelJol team in Hardoi organized the event to launch the programme in 62 schools. Children, teachers, Panchayat Raj Institution members, School Management Committee members, HCL Foundation and MelJol team were among the 400 participants. The event was a great success as children shared their expectations and learning on identity, rights and responsibility and savings with stakeholders.

Samuday (HCL) Team's training workshop

Samuday is the flagship programme of HCL Foundation for rural transformation in Hardoi district of Uttar Pradesh. As part of a larger contribution to the HCL Foundation and MelJol partnership, MelJol conducted a capacity-building workshop with HCL Samuday team in Hardoi. Thirty-seven members were trained on the Aflatoun Social and Financial Education Programme during this workshop. This training was very useful as HCL Samuday team helped MelJol implement the programme at 62 schools in Hardoi.

Teachers training workshop

Training of teachers is an important component of all MelJol programmes. The teachers are motivated to understand the concepts of social and financial education and also to imbibe skills to apply active learning methods with children. This year MelJol trained 901 teachers across 11 locations to conduct sessions on social and financial education with children.

Entrepreneurship Program in Varanasi

This was the second year of implementation of Aflateen Entrepreneurship Lab Programme with 25 aided high schools in Varanasi with partner PRYATN for field implementation. The programme reaches out to 800 adolescents, the majority of whom are from the lower economic strata of society. The learning has been immense and the enthusiasm of the youth about the programme has been encouraging.



Partnership with Chhatisgarh Government

2017 was a key year for MelJol in terms of partnerships with governments. MelJol worked with the Government of Chhatisgarh for the Rajiv Gandhi Shiksha Mission [RGSM]. It partnered with local partner NGO AHSA-Chhatisgarh to implement the Aflateen Social and Financial Education Programme. The outcomes of the programme were shared with RGSM. MelJol advocated the importance of social and financial education for children and demonstrated how children can participate and contribute in their own development process. The effort bore fruit as MelJol was selected to help the Chhatisgarh Government to roll out Child Cabinet Programme in their schools where children are democratically elected to form a cabinet that will discuss and find solution for their concerns in the school. The RGSM sees a wide scope in Aflateen social and financial education programme to establish and strengthen the child cabinets in the schools.

Knowledge partnership with ChildFund India

MelJol had been the knowledge partner of ChildFund India to implement Aflateen Social and Financial Education with school children in Odisha last year. Happy with the outcome, ChildFund India has continued its association with MelJol this year to implement Social and Financial Education Programme in 10 schools of Devghar, Jharkhand.

Knowledge Partnership with Plan India

MelJol has partnered with Plan India to help them implement the Aflateen Social and Financial Education programme with 1,400 schools in the district of Bikaner. This was the second year of implementation. As a part of its technical support, MelJol conducted field visits and refresher capacity-building workshop for URMUL SETU, field implementation partner of Plan India.

Aflatoun Bal Gram Sabha



MeJol started the Aflatoun Programme in 145 primary schools in Maregaon, Zari and Wani Blocks of Yavatmal District in Maharashtra. The Bal Gram Sabha was introduced in the villages of Maregaon as part of the programme process. The Bal Gram Sabha is a platform to hear the children's views on different issues that concern them in the village. All the Sarpanches (heads of the village gram panchayat) have shown a keen interest in providing such a platform to children. These efforts are very significant as the Village Education Committees mandated under local governance norms have merged into School Management Committees [SMCs]. The sarpanch will become the chairperson of the SMC and can address children's issues in schools and villages. In this way, children's active participation in decision-making can be seen as an important element in their development.

Aflatoun Resource Centre (ARC)

Aflateen Resource Centres [ARC] were conceptualized and opened in Mumbai, Pune and Delhi, as a single point of contact for members of the community. They are meant to be open and accessible to all, particularly the youth. They are intended to develop better connections with the communities. The ARC acts as a safe space for social and financial education. It is here that the Entrepreneurship Lab is formed and operated, to nurture the entrepreneurial potential within the youth. The ARC acts as the knowledge hub connecting 3-4 smaller units within the community where youth come together to learn. The ARC has a range of reading material, computers and other IEC [Information, Education & Communication] materials made accessible to the community members. The concept of the ARC has been well received by the community and there has been healthy participation in programme activities.

Career Counselling

The Entrepreneurship Skill Development Programme warranted a concentrated effort to make career counselling one of the key components in existing programmes.

It was first introduced in community interventions. There was a heartening response to this initiative with many adolescents, youth and parents turning up for career guidance sessions. The preliminary session on career opportunities was followed by a thorough scientific testing of aptitudes and personality traits of participants. Based on the results of the tests, suitable career paths were suggested by counsellors to the participants during the counselling sessions.



Working with communities

The Entrepreneurship Skill Development Programme has provided a unique opportunity for MeJol to test its programmes in urban communities. MeJol and its partner organizations have implemented the programme in communities, under-resourced informal housing areas in urban locations of Mumbai, Pune and Delhi. Intervention in the communities was facilitated by the Aflateen Resource Centres. These spaces have helped MeJol strengthen its connections with parents, community leaders and youth.

The socio-cultural fabric of many communities has undergone many radical and sudden changes; this has proved a challenge to all concerned. For instance, the mobility of the girls is often hampered. Despite these challenges the participation of girls in the ARC programmes was excellent.

Social Enterprises

Aflateen children at various locations have confronted issues of child rights and responsibilities in an innovative manner. The issues they addressed were child labour, hygiene, gender inequality, right to participation, etc. They also sought to recycle material for use. School Principals, SMC members, local shopkeepers, etc. extended support. They were considered partners in safeguarding the rights of the child.

Schools children from Mumbai, Thane and Yavatmal participated in this initiative. The school authorities, SMCs and parents too appreciated their efforts.



Citi Employees Volunteering Programme

The Citi Foundation supported MelJol last year, for employability preparedness in today's youth, in cities like Mumbai, Pune and Delhi. The Citi Technical Unit (CTU) based in Pune has shown great interest in volunteering for this programme. The CTU started to come as volunteers for to work with young girls and boys. The volunteering programme of CTU has been implemented with the active support of New Vision, the local partner organization of MelJol. The CTU team's dedication was noteworthy. It produced the desired impact efficiently and has given a good shape to the volunteering programme.

The volunteering plan was executed under the leadership of Kashmira Vakharia, Nilesh Nandoskar and Anurudh Sahay from the Citi Pune unit. Vishal Garg, Kapil Raut, Keya Pansare, Gupta, Srivally Thallapalle, Sharad Patel, Ankit Kachhara, Deepa Mohan, and Ashwin Patil, were the leaders of various plans who helped their teams in effectively delivering the plan on ground. The programme has received an overwhelming acceptance in communities and schools. Over 1,400 youth have benefited from the programme.

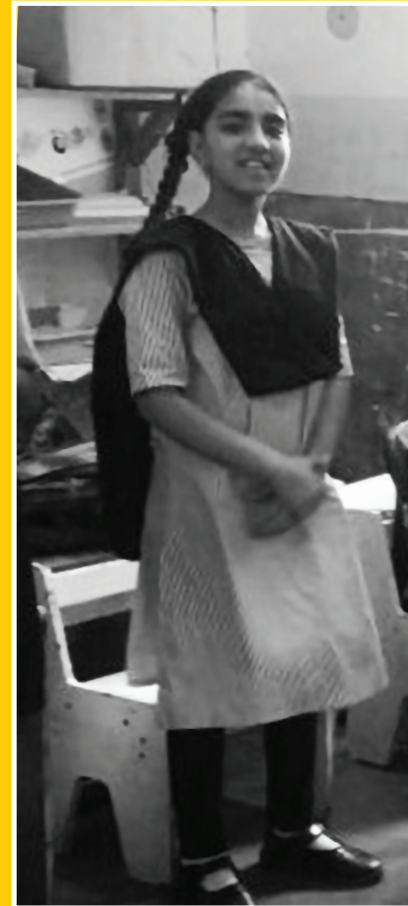
I developed my business idea and proposal with the inputs given by the MeJol team. I will share this learning with my friends in the community.

Muskan Makes a Change

Muskan Qureshi is a grade 6 student of Sainath Nagar Urdu School, Mumbai and belongs to a middle-class family. Muskan was very shy and used to keep quiet in the classroom. As the Aflatoun programme progressed, she started taking interest in the sessions; she started asking questions which helped her and others too.

At the time of renovation in her school, teachers were keen on shifting the books to some other place but they were not ready to take responsibility of the library as it would have become an additional burden. Muskan is passionate about reading and books. She decided to take responsibility of the books with support of her friend who was the club secretary. Every day both of them would take the books home and carry them back to school so that other children could read them as and when they were in school. Muskan is the President of an Aflatoun club and is also taking care of Aflatoun Library formed by children in her school.

Muskan and her friend have shown passion and also courage to share responsibilities. Their teacher Shabana Sayyad was always with them.

Creative Aflatouns



A child raised the issue of cleanliness in classrooms in one of the meetings of Aflatoun Club in Primary School Barwa Sarsand, Kachauna, Hardoi, Uttar Pradesh. The club members then discussed the problem and tried to work out solutions. They decided that all club members will make dustbins out of cardboard and use them in the school campus.

All children collected hard sheet and chart papers from used materials and made beautiful dustbins. The outer part of the dustbins was coloured with sketch pencils.

After this initiative by children the school head master has kept plastic dustbin in school campus. Now all children use the dustbins daily and maintain cleanliness in school campus.

Learner Avdesh

Avdes Gupta is a 6th grade child from Korba, Mitha-Nagar School Number 1 in Mumbai.

Avdesh introduced himself in class with his qualities and his love for reading while all others only told their names and the grade they studied in. He went on to say that he doesn't like interacting with his classmates in school. Both comments caught everyone's attention.

Avdesh was very good at studies, liked reading and he always wants to get better results in class. He would look down upon the weaker students in class. As the Aflatoun programme advanced Avdesh's attitude to his not-so-studious friends reduced. He started helping his peers instead of laughing at their weaknesses and complaining about them. He also acknowledged that his earlier attitude was wrong. Now, he is very active in class. He has made a poster of Aflatoun slogans. He urges his classmates to read it daily and reflect upon it.

During the summer vacation, he participated in Aflatoun sessions and motivated other children in his locality to attend the sessions. There are many positive changes in his attitude and behaviour. Now Avdesh has become everyone's friend.



Activist Muskan

Muskan Kumari, 14 years old, is a member of "Tagore Aflatoun Club". The sewage line passing by Muskan's school broke. This had caused a lot of inconvenience to the students and visitors.

There was an incident when a boy from the second standard from the same school fell in the sewage. Muskan helped him out. She was very angry with the authorities for not fixing the sewage line. Muskan complained about it to her Head Mistress who told her that the property falls under Hazaribag Nagar Palika hence the school could not do anything.

Muskan decided to write a letter to the Hazaribag Nagar Palika. To improve the language and structure of the letter she asked the Head Mistress Mrs. Lalita Sinha for help. The letter was sent to Hazaribag Nagar Palika. Nothing has been done in reply to the letter but this experience has helped Muskan gain confidence and understanding that some efforts may fetch results late but one must keep trying to find solutions.

Sujat Starts a Shop

Fifteen-year-old Sujat Maurya belongs to Lonhara, a village in Hardoi district of Uttar Pradesh. He is studying in the 8th standard. His father is a labourer and a small farmer.

Sujat had saved Rs.190 by the month of April. With this money he purchased 10 kg of mangoes from a mango farm. He sold them in the local market and earned Rs. 80 net profit. Sujat is a member of Aflatoun Child Savings Scheme in school. During the school vacation he continued to do this and saved money.

Sujat soon established a petty shop for his father with the guidance of his school teacher.

His father says "Sujat was always smart and proactive at taking different initiatives since a young age. Aflatoun programme has really help him think and act. We now want him to get higher education and grow up well."

Ankita Yadav is a std. V student at Rajapur School, Barabanki Uttar Pradesh. Ankita, a member of Aflatoun club, started a tree plantation drive all by herself.

Once when Ankita was playing in group under a tree, all children went to play kabaddi but Ankita stayed back under the tree. She started thinking about how trees provide shadow, fruits and a home for birds etc. She knew from her Aflatoun Club that trees also help control pollution but many trees are cut down for various purposes. She decided to take a step to save trees. Ankita discussed the issue with club members at the following meeting. After discussing the importance of saving trees, the members decided to plant trees. Ankita's initiative encouraged members of the club to take an active role and plant trees in the school campus.

Leader Sachin

The future belongs to those who believe in the power of their dreams. Sachin Yadav from Mumbai is a firm believer of this adage. When you meet Sachin, his vision is difficult to miss out on. He is a dreamer and knows that he has got the conviction to pursue his dreams. He always wants to believe that his circumstances cannot be an excuse for him to give up on them.

Sachin is currently pursuing his graduation. He is well aware of the fact that education can open newer avenues for him and enable him in bettering his social realities. Being the alert young lad that he is, he learned about the Entrepreneurship Lab programme through the MeJol facilitator visiting his community. His interest was spontaneously kindled and he enrolled for the programme. He was amongst the first few youths to enrol. For somebody who does not come from an entrepreneurial family, the idea of having an enterprise of his own gave him goose bumps. He was sure he had come to the right place.

Sachin realized that not many of his friends had joined the course. He soon started spreading the word and brought more of his young friends into the group.

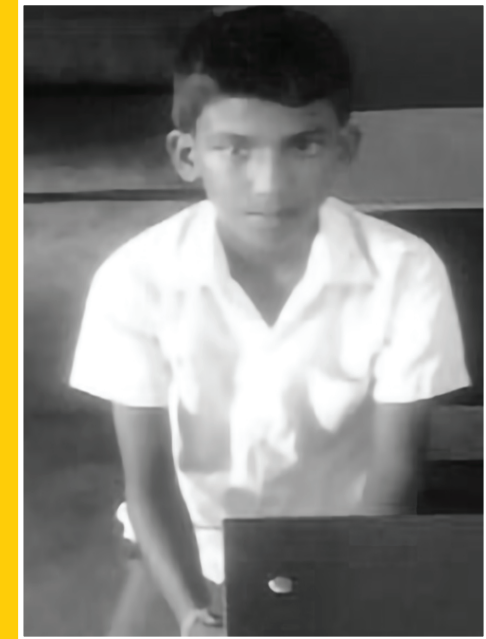
Realizing his initiative and latent leadership streak, he was offered the role of outreach worker for the programme.

Bold Sishu

Sishu Raj is a 13-year-old Aflatoun studying in the 8th class at Government Middle School, Pokhariya, Ichak, Hazaribag, Jharkhand. He is very active in the Aflatoun club. Although he comes from an underprivileged family, his background did not hold him back from speaking up for his rights.

Sishu Raj once was served rotten fruit during the mid-day meal programme by the school. He was upset about it and checked with his peers to see if they too had received rotten fruits. After discovering that many had received rotten fruit, he decided to collect them and complained to the Principal about it. He said, "I request you to take required action and get us fresh fruits as soon as possible or we all will refuse to take any kind of support from school." The Principal surprised, at first, subsequently was also impressed for his questions and arguments. Taking prompt action school management provided them good fruits in sometime.

The Principal said "The sessions taken by Aflatoun programme enhanced the speaking and negotiating skills, students now are well aware of their rights and their duties." Now the school has ensured that the quality of food distributed to the students is good.





Shruti Takes Action

Shruti Pandey is a student of Thane Municipal Corporation School Number 127. She participated in the Aflatoun Programme over the last year.

Shruti lives in Shanti Nagar in Thane. Now she is in grade 9 and she has taken admission at a school in Mulund. On her way to school, a man used to do some vulgar acts. She ignored the man for the first few times but then she observed that he was doing this again and again. She decided to take some action against him. Shruti discussed this incident with her friend and classmate, Aarti, in school.

Both of them informed their parents about the incident and the parents complained to the school principal regarding this. After hearing the complaint, the principal took immediate action against the person and after that Shruti and Aarti never saw that man in that area. Aflatoun sessions had sensitised Shruti about good and bad touch, child abuse, etc. The knowledge in the programme sessions about what should be the first response to such incidences had come in handy to Shruti.

Shruti dreams of being an engineer. Her father is a truck driver and so she knows that it would be difficult for him to fund her dream. Thus she is saving up and has already saved about 4000 rupees.

During the Child Labour campaign initiated by MelJol she interviewed child labourers. She came across some children not going to school due to work. She convinced them and helped them enrol in her school. Now two of them attend school regularly.
